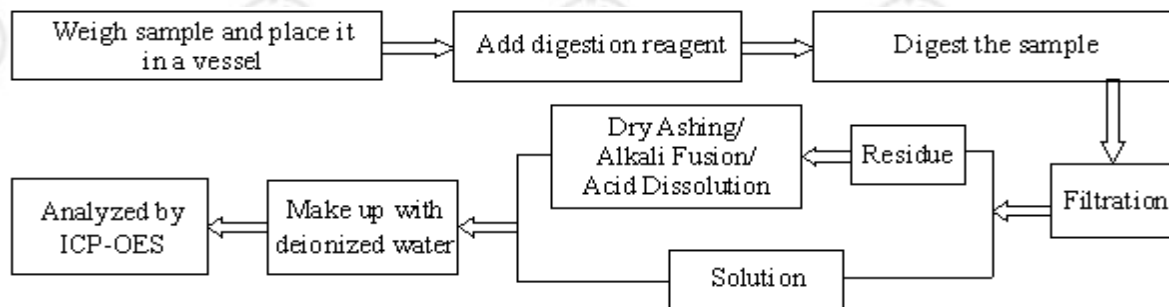

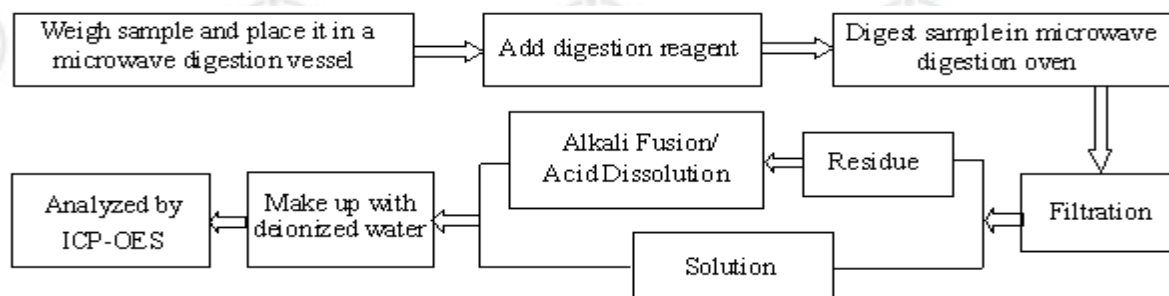

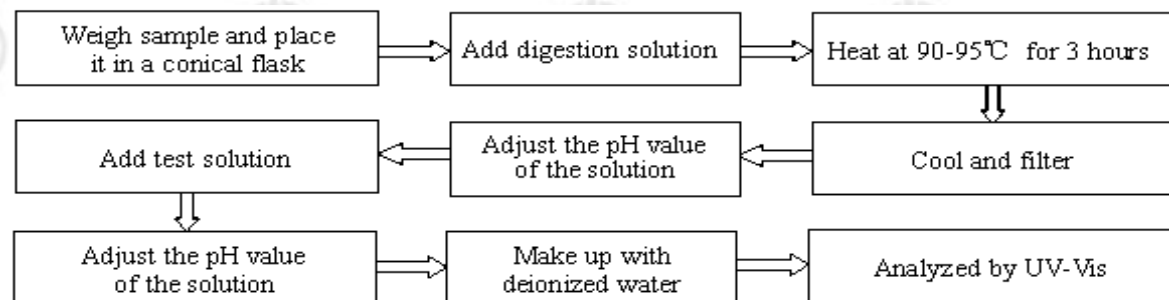
1. Lead (Pb), Cadmium (Cd)



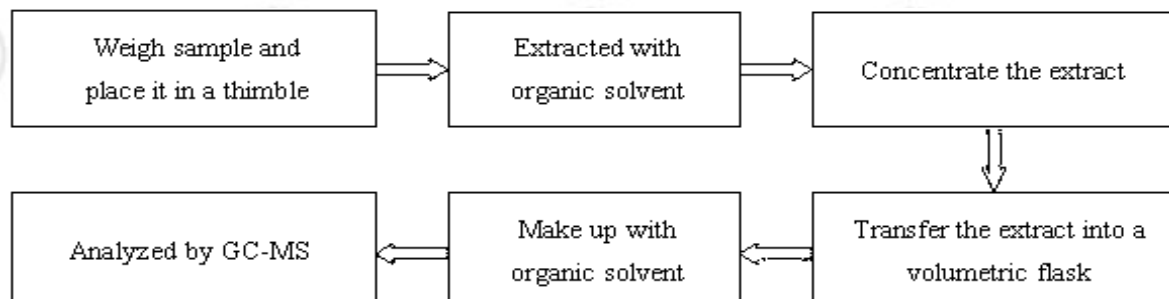
2. Mercury (Hg)
